**2009 ANNUAL REVIEW OF BODIES ABLE TO CARRY OUT SECTION 20 TESTS UNDER
THE FAMILY LAW REFORM ACT 1969 ON THE MINISTRY OF JUSTICE ACCREDITED
LIST**

Thank you for returning your signed undertaking and statement/evidence of adequacy that meets the requirements of the European Directive 95/46/EC to comply with the criteria for accreditation by the Ministry of Justice (MoJ), and also for providing evidence of a current and valid ISO 17025 Certificate. I am pleased to confirm that your company is to retain MoJ accreditation to carry out section 20 court-directed tests.

I would like to take this opportunity to remind you that we take very seriously any failure on your part to inform us of any suspension (temporary or otherwise) of your ISO 17025 accreditation. Our requirements clearly state that an organisation “will be removed from the MoJ accredited list on the expiry of its accreditation to ISO/IEC 17025. If the laboratory wishes to remain on the list the original or a certified copy of a renewed accreditation certificate must be forwarded to arrive on or before the expiry of the current certificate.” This includes a laboratory relocating to a new address and therefore undergoing a new accreditation procedure by UKAS. While we periodically monitor UKAS and other websites it is your responsibility to communicate to us immediately in writing any changes to your ISO accreditation status.

I would also like to add that the MoJ does not permit the use of intermediary organisations and failure to comply with this requirement could be grounds for us to withdraw an existing accreditation.

The courts have been notified of this position. I have enclosed a copy of the new list.
